North Carolina's Journey to Implement Collaborative Service Planning with Justice-Involved Youth - North

Carolina Department of Juvenile Justice and Delinquency Prevention implemented collaborative assessment and case planning to achieve more individualized treatment and service outcomes. Using the Youth Assessment and Screening Instrument (YASI) and Collaborative Case Work, North Carolina advanced a strength-based approach to more directly involve youth in service planning. Peacemaker Fellowship is a community violence intervention strategy dedicated to ending cyclical and retaliatory gun violence by investing in the healthy development and well-being of individuals at the center of conflicts. Storytelling for Systemic Reform - Nationally, girls represent about a third of juvenile justice referrals. Behaviors that push girls into the justice system are directly related to their lived experiences of trauma and exploitation. Youth-led activism is a powerful tool that bridges individual healing with social change. Creating a Trauma-Informed Courtroom - Trauma has always been pervasive across the child welfare and juvenile justice systems. The Covid-19 pandemic and the country's more recent racial reckoning have made the impacts of trauma even more profound. Because judges and lawyers often play a pivotal role in either exacerbating or abating a child or family's trauma, this workshop will address the impact of trauma and discrimination on brains and behavior. The session will also offer specific tools and strategies to create a trauma-responsive courtroom, which can change the trajectory of a child or family by improving permanency outcomes in child welfare, reducing recidivism in juvenile justice, and most importantly providing litigants with a greater sense of due process and fairness.

Leveraging Cross-Sector Resources to Enhance Prevention –

D.C. has several initiatives that are centered around prevention and are operationalized through coordinated, cross-sector resources and partnerships. Addressing issues from truancy reduction to violence prevention, D.C. is leveraging allies across disciplines to improve outcomes for youth and families. Supporting a Collaborative Approach to Improving Youth

Interactions through Law Enforcement Training - Officers are

not trained to work with youth. Most law enforcement agencies don't have policies regarding youth interactions, and even fewer have initiated partnerships with youth programs. It's time for that to change. COALITION FOR JUVENILE JUSTICE (CJJ).
REGIONS OF STATE ADVISORY GROUPS

The composition of the JJDPAs State Advisory Groups (SAGs) regions is defined in the CJJ Bylaws. Each region's members are represented on the CJJ Executive Board by a Regional Chair and 1-to-2 Regional Representatives. Memberships in CJJ are granted to all SAG members, as well as the state staff that work on JJDPAs matters with the SAG (including the state Juvenile Justice Specialists, DMC Coordinators, and Compliance Monitors).

The Chair/Chair-designee of each CJJ member-SAG has a vote in all proceedings of the CJJ Council of SAGs. The Council is responsible for Bylaws, electing Officers to the Board, and approving major policy positions. The Council of SAGs shall meet at least once annually. The CJJ Executive Board convenes at least 4 times per year to act as the governing body for legal, fiscal and strategic decisions, reflecting the views of CJJ members and stakeholders.

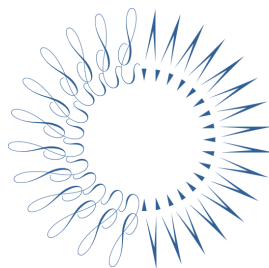
